

Activities

Estonia's youth sector is a kaleidoscope of opportunities inviting young individuals to engage, learn and be supported in a multitude of ways.

Hobby activities

Many engage in hobbies in schools, youth centres, and youth associations.

Hobby education

Over 800 hobby schools. 54% of 7-16 year-olds and 11% of 17-26 year-olds attend.

Open youth centres

299 youth centres all over Estonia provide a safe space and are used by 31% of Estonian young people.

Youth camps

11% of Estonian young people participate.

Youth projects

Youth meetings, youth initiatives, Erasmus+ & European Solidarity Corps participants.

Youth work services in local municipalities

Work camps

Multiple organisers, thousands of participants.

Youth associations

11% of all Estonian young people belong to youth associations and organisations.

Youth participation

20% of young people participate in local youth councils, action groups or student councils.

Discover Estonia

In Estonia, the law recognises the rights of youth and student councils, and **young people can vote from the age of 16**. The nation's evidence-based and data-driven youth sector aims to create an Estonia where young people want to live and have a voice.

Our goal is to make Estonia a country that **young people want to live in and lead**.

We want to increase young people's trust in state. From a 53% trust rate in 2016, the goal is to reach 70% by 2035.

Facts & numbers

Youth work creates conditions for diverse development of all young people. **As many as 90% of those involved in youth work are very satisfied** with the experience.

Key characteristics

OECD considers Estonian youth policy to be **one of the best in Europe**. Estonian youth sector development plan won the "Future Policy Award 2019" acknowledgement from the World Future Council.

- + Young people have a say in decisions that affect them: **voting rights start at age 16** in local elections.
- + The rights of **student** and **youth councils** are enshrined in law.
- + **Hobby education**, an integral part of the youth sector, provides its own curricula that enable broad self-development options in areas including music, arts, sports, and technology.
- + With three Bachelor's and one Master's programmes, Estonia prioritises **professional youth work education**.
- + State-coordinated but youth-driven **youth information portal** provides crucial information on education, career, relationships, health, etc, and is widely used.
- + **Diverse support for young people**: From tackling NEET challenges to special programmes for talented young people.
- + **Quality of youth work** is supported by a quality assessment model actively used by local governments.
- + Estonia's youth sector's future is directed by **Youth Sector Strategy 2035**, developed in collaboration with all stakeholders.
